Compassionate appointment of Sh. Farooq Ahmed S/o Late Sh. Ghulam Hassan & Late Smt. Hajra Begum R/o Mohalla Dhak Sadeeq Abad Doda in terms of SRO-43/1994.

ORDER NO: -798-NG OF 2023 DATED: - 25 -11-2023

As per the approval conveyed by the Adminstrative Department vide letter No. HD-NG-J/06/2021-02(C.No-14658) dated 14.11.2023, **Sh. Farooq Ahmed S/o Late Sh. Ghulam Hassan & Late Smt. Hajra Begum R/o Mohalla Dhak Sadeeq Abad Doda** is hereby appointed as Class-IV/MTS under SRO-43 of 1994 in the pay Level of SL1 (14800-47100) in relaxation of qualification/Upper age bar in terms of SRO-43 of 1994 on regular/ temporary basis and adjusted at **CMO,Office, Doda** against an available vacancy.

The appointee shall report to Chief Medical Officer, Doda within 21 days, from the date of issue of this order, who shall allow the candidate to join only after proper verification of all original documents/certificates as mentioned below.

- 1. Dependent Certificate.
- 2. Academic Qualification certificates.
- 3. Domicile Certificate issued by competent authority.
- 4. All other relevant documents as are required under SRO-43 of 1994.
- 5. That if the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District, Industries Centre (DIC) and District Employement and counseling Centre of the domicile District, he/she shall relingquish the proprietorship of the unit/enterprise and also stakes, if any in such self-employement unit/enterprise before joining the Government Service. He/she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary, DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such self-employment unit/enterprise and recovery to be made and also personally monitor its recorvery.
- 6. Health/ fitness certificate issued by concerned CMO.

The appointment of the candidate shall be subject to the following conditions:-

- i. The candidate shall be on Probation for a period of two years.
- ii. The appointee shall give an undertaking duly attested by the First Class Judicial Magistrate in the shape of an affidavit to the effect that:-

- a) If on verification by the concerned DDO, the qualification certificates/documents are found forged, false or fake, the appointee shall have no claim for appointment & this order shall be treated as null & void abinitio.
- Salary of the appointee shall not be drawn and disbursed unless and until the satisfactory reports/genuiness of the certificates in respect of condition (ii) (a) is received.
- iv. The appointment of the candidate shall be subject to outcome of the writ petion(S), if any, pending before any Competent Court/Tribunal etc.
- v. The appointment of the candidate shall be governed under new pension scheme sanctioned vide SRO-400 of 2009 dated -24-12-2009 issued by the Finance Department.
- vi. The candidate if fails to join within stipulated time period of 21 days shall forego his right of appointment which shall be deemed to have been cancelled ab-initio without any further notice as per the instructions issued by GAD vide circular No. 08-JK(GAD) of 2019 dated 04.12.2019.
