
Whereas, some representations / objections were received in this office which were considered and thereafter a Revised Tentative Seniority list of Junior Pharmacist District Cadre Kathua was again circulated vide this office Notification No.:- DHSJ/ Es-2/278/R-23/3859-64 dated 09.06.2023 which was also published in the News Paper State Times in its edition at Page No. 12 dated 18.06.2023 for filing objections if any with regard to their placement etc within 10 days positively, this office received some representations from Junior Pharmacists for inclusion of name , for correction of date of birth / date of appointment and categories etc . All these representations have been examined and after making necessary corrections, wherever required, subject to the condition that, after the lapse of stipulate period of time no representation shall be considered/entertained, and the Revised Tentative Seniority list is being finalized which is forming Annexure "A" to this notification.

However, the date(s) of birth recorded in the list shall not be taken as authentic but shall be subject to verification from service book// Matriculation Certificate/promotion order.

Further, this seniority is subject to outcome of any writ petition pending in any competent Court of Law as well as shall be subject to further instructions concerning reservation in Govt. service by promotion, the subject matter whereof is pending in the Hon'ble Supreme Court of India.

The Reserved category/qualification status reflected in the seniority list shall be subject to its authentication and verification from the competent issuing authority. In case reserved category certificates(s) furnished by any official is found to be false/fake later on, the same shall be deemed to have cancelled ab-initio and all the benefits which the official(s) would have availed on the basis of such false/fake certificates shall stand withdrawn from the date of receipt of such benefits by him/her. Besides, appropriate disciplinary action under rules shall be taken against him/her.


