Subject:- Last Notice for submission of documents/certificates for Compassionate appointment under SRO-43/1994.

Whereas, Staff Officer Director General of Police, Prisons Department, J&K Srinagar vide his endosrsement no. Estt/1593/2019/7545-47 dated 17.10.2019 had forwarded the application of Sh. Abhinandan Gorka S/o Late Dr. Bishan Lal Gorka R/o Chak Manga Rakwal, Tehsil and District Samba for compassionate appointment under SRO-43 as the father of the applicant expired while in active service as Medical Officer in District Jail Kathua on 29.03.2019, and;

Whereas, the applicant had been informed through the Chief Medical Officer concerned to furnish the following deficient documents vide this office letter No. DHS/J/Es-5/NG/448/18460-61 dated 26.02.2020,and;

Whereas, this office has served a notice vide letter No. DHS/J/Es-5/SRO-43/448/17990-94 dated 28.03.2023 to said applicant with the direction to furnish the requisite documents/certificate through concerned Chief Medical Ofifcer to this office within a period of 10 days from the date of publication of said notice in news paper otherwise his case for compassionate appointment under SRO-43 shall be rejected. After that the applicant has submitted a application dated 08.04.2023 wherein he has stated that he is pursuing B.Tech at Chandigarh and is unable to submit to required documents. Further, this office has communicated to the Administrative Deaprtment vide letter No.DHS/Es-5/NG/448/2400 dated 20.05.2023 that the candidate has failed to furnish the requisite documents till date and the Administrative Department has directed to this office vide letter No. HD.Gaz0Gen/552/2023-02(E-7212997) dated 15.06.2023 to furnish the requisite formalities/documents and same informed to the concerned DDO. Again the mother of the applicant namely Smt. Sunita Kumari has approached this office by way of an application dated 02.11.2023 and stated that her son is still pursuing B Tech Civil Engg. (6th Semester) and he will come home on 08.11.2023 and only thereafter the requisite documents can be submitted and accordingly and the same information submitted of the Administrative Department vide this office letter No. DHS/Es-5/NG/448/11299-11302 dated 04.11.2023.

Now, again, the Administrative Department has intimated to this office to issue final notice to the applicant for submitting the relevant documents within a period of five days failing which the GAD shall be apprised that the candidate has failed to produce the requisite documents.

- Undertaking of the applicant to the effect of taking care of all dependents and affidavits of all the dependents indicating no objection in case the applicant is appointed under SRO-43/94 duly issued/sworn in the Court of Ist Class Judicial/Executive Magistrate.
- Dependent Certificate issued by Assistant Commissioner Revenue, concerned Indicating age and occupation of all the dependents, who are actually dependent on the deceased at the time of his/her death, alongwith seal, as stipulated in sub-rule (iii) of Rule-2 of SRO-43/94.
- 4. Photocopy of the service book of the deceased official duly attested by the concerned DDO.
- 5. All original documents as required under SRO-43/94.
