As recommended by the Service Selection Board vide No. JKSSB/Sel/Secy/ 2023/ 684-88 dated 01-06-2023 endorsed by the Administrative Department vide letter No. HD-NG-J/188/2023-02 dated 21-06-2023 and after receipt of a satisfactory report with regard to character and antecedents from Criminal Investigation Department (CID), sanction is hereby accorded to the appointment of candidates as **Junior Laboratory Technicians** on temporary basis in District Cadre Jammu / Ramban & Udhampur in the Pay Level-4 (25500-81100) and adjusted at the places shown against each as **Annexure-A** to this order.

The appointees shall report to the Directorate of Health services, Jammu within a period of 21 days from the date of issuance of this order in case he/she fails to join within in this period, his/her appointment(s) shall be deemed to have been cancelled ab-initio without any further notice.

The appointee shall be allowed to join only on the production of the following certificates in original:-

- Academic Qualification Certificate
- Matriculation/Date of Birth Certificate.
- Health certificate issued by the Chief Medical Officer.
- Domicile Certificate issued by the Competent Authority.
- That if the candidate has taken any loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District employment and counselling Centre of the domicile District, he/she shall relinquish the proprietorship of Unit/enterprise and also stakes, if any, in such Self employment Unit/ enterprise before joining the Government service. He /she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his /her salary, DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such self- employment Unit/enterprise and recovery to be made and also personally monitor it recovery.
- Relevant category certificate(s), (in case of candidates belonging to reserved categories).
- Any other certificates/documents are required under rules/norms.

The above appointment shall further be subject to the following conditions:-

The appointee/s shall have to give an undertaking duly attested by the First Class Judicial Magistrate in the shape of an affidavit to the effect that:-

- a) If on verification from the concerned issuing authorities, the qualification certificate/reserved category certificate/experience certificate (wherever applicable) is found forged, false or fake, the appointee/s shall have no claim for appointment.
 - b) Salary of the appointee/s shall not be drawn and disbursed to them unless and until a satisfactory report/genuineness of the certificates in respect of Condition i (a) is received.
 - c) The appointment of the candidates shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24-12-2009.
 - d) Appointee/s shall abide by all the terms and conditions as laid down in his/her appointment order.
 - e) The appointee/s shall be on probation for a period of two (02) years.
 - f) Appointee/s have no criminal records and also not facing any criminal proceedings in any Court of Law.
 - g) Appointee/s shall be liable for action as warranted under rules for violating any of the laid down conditions as indicated in the appointment order.
- ii) The inter-se-seniority of the appointee/s shall be drawn in accordance with the merit secured by the appointee(s) in the selection list prepared by the Service selection Board.
- iii) The order issued is without prejudice to the outcome of any petition/s pending before any competent court of law/Tribunal etc.


