Sub: Appointment of Junior Theatre Technicians / OT Technicians (District Cadre, Reasi) in Health Department in the Pay Level-4 (25500-81100).

**ORDER NO. 617 DHSJ of 2023**  
**Dated 27-09-2023**

As recommended by the J&K, Service Selection Board vide No. JKSSB-SDOSecy(UT)/1/2023-01(E-7099079) dated 27-06-2023, endorsed by the Administrative Department vide letter No.:- HD-NG-J/198/2023-02 dated 17.07.2023 and after the receipt of a satisfactory report with regard to character and antecedents from Criminal Investigation Department (CID), sanction is hereby accorded to the appointment of candidates as **Junior Theatre Technicians/OT Technicians** on temporary basis in District Cadre Reasi in the Pay Level-4 (25500-81100) and adjusted at the places shown against each as per **Annexure-A** to this order.

The appointees shall report to the Directorate of Health Services, Jammu within a period of 21 days from the date of issuance of this order in case he/she fails to join within this period, his/her appointment(s) shall be deemed to have been cancelled *ab-initio* without any further notice.

**The appointees shall be allowed to join only on the production of the following certificates in original:-**

- Academic Qualification Certificate.
- Matriculation/Date of Birth Certificate.
- Health Certificate issued by the Chief Medical Officer.
- Domicile Certificate issued by the Competent Authority.
- That if the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and counselling Centre of the domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment Unit/enterprise before joining the Government Service. He/she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his /her salary, DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- Relevant category certificate(s), (in case of candidates belonging to reserved categories).
- Any other certificates/documents are required under rules/norms.

**The above appointment shall further be subject to the following conditions:-**

- i) The appointees shall have to give an undertaking duly attested by the First Class Judicial Magistrate in the shape of an affidavit to the effect that :-
  - a. If on verification from the concerned issuing authorities, the qualification certificate/reserved category certificate/experience certificate (wherever applicable) is found forged, false or fake, the appointee(s) shall have no claim for appointment.
  - b. Salary of the appointee(s) shall not be drawn and disbursed to them unless and until the satisfactory report/genuineness of the certificates in respect of Condition i (a) is received.
  - c. The appointment of the candidates shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
  - d. Appointee(s) shall abide by all the terms & conditions as laid down in his /her appointment order.
  - e. The appointee(s) shall be on probation for a period of two (02) years.
  - f. Appointees have no criminal records and also are not facing any criminal proceedings in any Court of Law.
  - g. Appointee(s) shall be liable for action as warranted under rules for violating any of the laid down conditions as indicated in the appointment order.
- ii) The inter-se-seniority of the appointee(s) shall be drawn in accordance with the merit secured by the appointee(s) in the selection list prepared by the Service Selection Board.
- iii) The order issued is without prejudice to the outcome of any petitions pending before any competent court of law/Tribunal etc.
