Sub:- Appointment of Dhobi (District Cadre, Doda) in Health Department in the Pay Level-2 (19900-63200).


ORDER NO. 291 DHSJ of 2024

As recommended by the J&K, Service Selection Board vide No. JKSSB/Sel/Secy/2023/964-67 dated 20.10.2023, endorsed by the Administrative Department vide letter No. HD-NG-J/279/2023-02(CC. No. 7329933) dated 17.11.2023 and after the receipt of a satisfactory report with regard to character and antecedents from Criminal Investigation Department (CID) and in terms of Office Memorandum issued by GAD vide Civil Secretariat, Jammu/Srinagar dated 19.03.2024, regarding enforcement of Model Code of Conduct, sanction is hereby accorded to the appointment of **Momen Noor S/o Noor Mohammad Dhobi R/o Syed Hamid Pora Nawab Bazar Srinagar** as Dhobi on temporary basis in **District Cadre Doda**, in the Pay Level-2 (19900-63200) and adjusted at SDH, Baderwah against clear vacancy.

The appointees shall report to the Directorate of Health Services, Jammu within a period of 21 days from the date of issuance of this order in case he/she fails to join within this period, his/her appointment shall be deemed to have been cancelled ab-initio without any further notice.

The appointees shall be allowed to join only on the production of the following certificates in original:-

- a. Academic Qualification Certificate.
- b. Matriculation/Date of Birth Certificate.
- c. Medical Fitness Certificate issued by the Chief Medical Officer.
- d. Domicile Certificate issued by the competent authority.
- e. That if the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District, Industries Centre (DIC) and District Employment and counseling Centre of the domicile District, he/she shall relinquish the proprietorship of the unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government Service. He/she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary, DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- f. Relevant category certificate (s), (in case of candidates belonging to reserved categories).
- g. Any other certificate/documents are required under rules/norms.




- i. The appointee shall have to give an undertaking duly attested by the First Class Judicial Magistrate in the shape of an affidavit to the effect that if on verification from the concerned issuing authorities, the qualification certificate/reserved category certificate/experience certificate (wherever applicable is found forged, false or fake, the appointee shall have no claim for appointment.
- ii. Salary of the appointee shall not be drawn and disbursed unless and until satisfactory report/genuineness of the certificates is received.
- iii. The appointment of the candidates shall be governed by the "New pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- iv. Appointee shall abide by all the terms & conditions as laid down in his/her appointment order.
- v. The appointee shall be on probation for a period of two (02) years.
- vi. Appointee have no criminal records and also is not facing any criminal proceedings in any Court of law.
- vii. Appointee shall be liable for action as warranted under rules for violating any of the laid down conditions as indicated in the appointment order.
- viii. The inter-se seniority of the appointees be drawn in accordance with the merit secured by the appointee in the selection list prepared by the Service Selection Board.
- ix. The orders issued are without prejudice to the outcome of any petition pending before any competent court law/Tribunal etc.
