Subject:-O.A.No.61/1178/2022 titled Zumurad Hussain Vs UT of J&K &
Ors.

ORDER

Whereas, the Hon'ble Central Administrative Tribunal, Jammu Bench has disposed of the above titled Original Application, on 01-09-2022, with the judgment/order whose operative portion reads as under:-

"Considering the submission made by the Ld. Counsel for both the parties and having perused the material on record and without commenting on the merits of the case, the O.A. is disposed of with direction to the respondents to consider and decide the pending representation of the applicant dated 22-08-2022 by passing a reasoned and speaking order within a period of four weeks from the date of a certified copy of this order. A copy of the speaking order shall be communicated to the applicant within one week thereafter. Till decision is taken on the representation, status quo as on today qua the applicant be maintained."

Whereas, the applicant in the representation has stated that by virtue of order dated 20-08-2022 he has been adjusted in PHC Nakka Manjhari after his promotion as Sr. Pharmacist, despite of the fact that the said place of adjustment is more than 100 kms away from his residence and due to his disability he is unable to perform duties at his place of adjustment. He has further stated that before making his adjustment he has already supplied medical record and while making adjustment the record has not been taken into consideration and accordingly has requested for modification of his adjustment and as per medical record appended with the Original Application he is suffering from 50% disability.

Now, therefore, in compliance to Hon'ble CAT orders, the case of the applicant is accorded consideration and keeping in view the medical condition of the applicant, the order of adjustment of Sr. Pharmacists issued by this Office vide No:-344 NG of 2022, dated 20-08-2022, is modified to the extent of adjustment of Sh. Zumurad Hussain and he is now adjusted at NTPHC Dodaj, Block Darhal, District Rajouri against the post of Sr.

Pharmacist fallen vacant due to retirement on superannuation of Sh. Javaid Akhter, Br. Pharmacist, Sh. Zumurad Hussain shall have to join the place of his new adjustment within ten days positively from the date of issue of this order otherwise his promotion shall stand cancelled. The period of joining of the applicant is extended accordingly as an exceptional case in view of Status Quo order granted by the Hon'ble CAT. However, the benefits of promotion shall accrue to the applicant from the date of joining on the promotional post.
