Subject:-O.A.No.61/1224/2022 titled Kewal Krishan Singh Vs UT of J&K &  
Ors.

## ORDER

Whereas, the Hon'ble Central Administrative Tribunal, Jammu Bench has disposed of the above titled Original Application, on 06-09-2022, with the judgment whose operative portion is reproduced verbatim as under:-

*"I have considered the submissions made by the Ld. Counsels for both the sides and perused the material on record. Without commenting on the merits of the case, the O.A. is disposed of at this stage, with direction to Respondent No. 2 i.e. Director Health Services, Jammu to consider the representation dated 24-08-2022 submitted by the applicant and decide the same, as per rules and regulations governing the subject, by passing a reasoned and speaking order within a period of three weeks from the date of receipt of a certified copy of this order."*

Whereas, the applicant in the representation dated 24-08-2022 annexed with the O.A. has stated the ailment of his son claiming that his son had met with a road traffic accident in which he had suffered with serious head injury and after treatment has recovered to some extent but has lost his memory and still on bed in unconscious condition. His son is in need of his presence for his better medical treatment and other basic amenities of life in view of the fact he is unconscious and accordingly has requested to modify his adjustment order by adjusting him to his home district, and;

Whereas, fresh medical board certificate forwarded by the Chief Medical Officer, Rajouri, vide letter No:-CMO/R/2022-23/6170-71, dated 19-10-2022, confirms the ailment of son of the applicant.

Now, therefore, in compliance to Hon'ble CAT orders, the case of the applicant is accorded consideration and keeping in view the medical condition of son of the applicant, the order of adjustment of Sr. Pharmacists issued by this Office vide No:-344 NG of 2022, dated 20-08-2022, is modified to the extent of adjustment of Sh. Kewal Krishan Singh only and he is now adjusted against the post of Sr. Pharmacist at Leprosy Control Unit CMO

Office Rajouri by extending the period of joining as exceptional case with the stipulation that the benefit of promotion shall accrue to the applicant from the date of joining the promotional post which shall be within seven days from the date of issue of order otherwise his promotion shall stand cancelled.
