
Whereas, after the lapse of stipulated period of time no representation shall be considered / entertained, and the Revised Tentative Seniority list shall attain finality.

Further, this seniority is subject to outcome of any writ petition pending in any competent Court of law as well as shall be subject to further instructions concerning reservation in Govt. service by promotion, subject matter whereof its pending in the Honble Supreme Court of India .

The Reserved category/qualification status reflected in the seniority list shall be subject to its authentication and verification from the competent issuing authority. In case reserved category certificates(s) furnished by any official is found to be false/fake later on, the same shall be deemed to have cancelled ab-initio and all the benefits which the official(s) would have availed on the basis of such false/fake certificates shall stand withdrawn from the date of receipt of such benefits by him/her. Besides, appropriate disciplinary action under rules shall be taken against him/her.
