In case reserved category certificates(s) furnished by any official is found to be false/fake later on, the same shall be deemed to have cancelled ab-initio and all the benefits which the official(s) would have availed on the basis of such false/fake certificates shall stand withdrawn from the date of receipt of such benefits by him/her. Besides, appropriate disciplinary action under rules shall be taken against him/her.
