Subject:-O.A./1471/2022 titled Arun Singh Vs U.T. of J&K & Ors.

ORDER

Whereas, the applicant has filed the subject captioned application in the Hon'ble Central Administrative Tribunal, Jammu Bench wherein it has been averred that he was appointed as Class IV on 31-07-2007 in District Doda and in the year, 2011 he was adjusted as Junior Assistant in his own pay and grade vide order dated 29-06-2011. The applicant has further claimed that he has been confirmed as Jr. Assistant in the recently held DPC w.e.f.01-08-2022 despite the fact that he is serving on the post of Junior Assistant w.e.f. 29-06-2011. The applicant is seeking notional promotion as Junior Assistant w.e.f. 29-06-2011 alongwith all consequential benefits on the analogy of similarly situated officials who have been extended the benefit of promotion from the date they have been adjusted on OPG basis, vide this office order No:-DHSJ/Es-5/NG/75/6931, dated. 28-08-2018 & No:-Es-4/347/NG/of 2022, dated.20-08-2022, and;

Whereas, from the perusal of record it has come to fore that the applicant was appointed as Class-IV (Nursing Orderly) under SRO-43 vide Order No:-492/NG of 2007, dated 31-07-2007. The applicant passed the type test on 24-02-2011, conducted by the department and subsequently he was adjusted as Junior Assistant in his own pay and grade against available vacancy in District Doda on charge allowance basis, and;

Whereas, the applicant has been promoted as Junior Assistant, vide Order No:-283 NG of 2022, dated 20-08-2022, giving the benefit of promotion w.e.f. 01-08-2022 (Notionally), and;

Whereas, it has been observed that in the recently held DPC some of the categories have been given the benefit of confirmation of promotion retrospectively from the date of their OPG promotion, vide Order No:-Es-4/347/NG/of 2022, dated.20-08-2022, and;

Whereas, the General Administration Department has laid down guidelines for regularization of promotions vide Govt. Order No:-743-GAD of 2007, which states, inter-alia, that clearance/regularization of Govt.

Employee shall take effect from the date of his placement against the higher post or availability of vacancy or acquiring of his eligibility, whichever is later.

Therefore, sanction is hereby accorded to the notional confirmation of promotion of Sh. Arun Singh, as Jr. Assistant retrospectively w.e.f. 29-06-2011.
