Sub : Show Cause Notice.

Whereas, vide Govt. Order no. 912-JK(HME) of 2023 dated: 13.11.2023, in-depth enquiry was ordered into procurement of 70 KVA AVR and other goods by the then BMO Nowshera in respect of the complaint lodged by Sh. Rajiv Sahni, M/S Shanker Enterprises, Shastri Nagar Jammu.

Whereas, the Inquiry Officer after conducting enquiry into the matter submitted it's report on 01-01-2024 observed following discrepancies in the said procurement:-

1. No administrative approval has been sought from the higher authorities for effectuating the said purchase.
2. No funds were available for the said purchase in question neither was there any plan or estimate formulated for purchase.
3. No Technical agency/department Viz, Mechanical engineer wing or PDD was involved for determining the technical requirement, specifications of the equipment and feasibility report vis-à-vis the estimate of installation & item cost.
4. No requisition has been made to JKMSCL for effectuating the said purchase.
5. There is no record of installation/stock entry in concerned store books/ store register, whereas the said CRAC of the said item is raised.
6. No committee has been framed at District level for effectuating such a huge purchase, which indicates arbitrariness in decision making.
7. Effectuating purchase without funds is a gross irregularity in terms of general financial canons and standing guidelines.
8. On inspection by the committee the said item AVR were seen installed in the said hospital however, the specification of the item needs to be verified as per the supply order/bill.

Whereas, you were entrusted and assigned to look after the works of Block Nowshera w.e.f 17.10.2022, without being delegated any financial and administrative powers and you impressed the supplier for supply and installation of AVR, when there were no funds available and threatened to blacklist the supplier . Moreover, while performing only the look after duties accorded of the financial approval of purchase for busbar and wiring accessories beyond your competence.

Whereas, the Inquiry officer has recommended for disciplinary action under CCA Rules 1956 against you for willful and intentional escapism and laxative approach in your legitimate duties.

Therefore, you are directed to show cause as to why disciplinary action as warranted under rules may not be initiated against you for making procurement without following the codal formalities. Your reply must reach in this office within seven days positively other wise it shall be presumed that you have nothing to say in your defence and the department shall proceed against you accordingly.
